Development of the ETC and how it is organized, has changed for the better during 2020. Our aim is to build a strategy of communication with the Feldenkrais community in order to help ETC in focusing on relevant matters to the community.

Information flow - transparency – efficiency – involvement

ETC-relation with the community has got closer in 2020:

e.g. questions from Guilds on different matters has been dealt with by reps in digital meetings.

ETC and their working group on accreditations, ETAB, has enhanced their

cooperation:

e.g. Covid-situation and questions from training on digital versions, extra ETC-GA to vote on candidates to come onboard as members of ETAB in a reasonable time to ensure the further work of our TAB. The National Accreditation Board in Italy met challenges – solution found in dialogue with the parties involved

In addition to other challenging situations where we benefit from finding the solutions together.

To take qualified and more efficient actions in ETC, we decided to utilize resources, knowledge and interests of the etc reps. We established task groups on relevant issues that benefits from extra interest and knowledge within the group of reps, to ease and secure the follow up – processes and shorten the way to qualified conclusion: reported enhanced engagement and enthusiasm

Every ETC-rep. Is participating in minimum one task group which again reports to the whole council for actions. e.g. Newsletter, Webpage, administration/archive/formulas. Projects include Assessment Tool, Alternative Pathway.

The task groups are still exploring and evaluating their form and to develop further with efficiency and quality in mind. During 2020, changes to the book-keeping were introduced to increase transparency and reduce repetition and reduce future costs, more details are in the Finance report below.
